Support for Businesses in Trafford:

- **Business Interruption Loan Scheme:** The Coronavirus Business Interruption Loan Scheme was launched today. SMEs can avail of up to £5m of funding, repayable over 6 years, interest free for the first 12 months. Government will provide a guarantee of 80% against the loans. Further details of loan terms can be viewed [here](#). Applicants are encouraged to apply direct to lenders. - **Coronavirus Job Retention Scheme:** All UK businesses which furlough workers as a consequence of Covid-19 can apply for the scheme which will see government reimburse 80% of furloughed workers' wage costs, up to a cap of £2,500 per month. HMRC are working urgently to set up a system for reimbursement. For the latest information click [here](#). Businesses with outstanding tax liabilities, may be eligible to receive support with their tax affairs through HMRC's Time To Pay service - contact the dedicated helpline - 0800 0159 559.
- **The Growth Company:** The Growth Company has published on its website a list of the **top ten priorities** for businesses to consider. These include keeping informed, signposting employees, measures for hygiene, managing self-isolation, international travel, assessing risks in the supply chain, insurance and pandemic planning.
